### Eligibility...

- While Chamber membership is not a requirement for those nominated and living and/or employed within Monroe County, nominees living outside of Monroe County must be a Chamber member in good-standing.
- Any living individual 21 to 40 years of age at the time of nomination is eligible and may be with profit or not-for-profit, and from either the private or public sector.
- The nominee provides outstanding leadership in influencing the growth of others in the community and their organization; Serves as a an example and mentor to others.
- Nominee has made an important and noticeable contribution to their community and/or organization.

### Notification of Nomination ...

- We ask that you please take the time to inform the person that you will be nominating them (via phone, in person, email etc). Awardees and nominees will be invited to the 2011 "10 Under 40" Awards Dinner hosted by The Greater Bloomington Chamber of Commerce and hYPe.

### Requirements...

- Nominators must complete the attached nomination form with all questions answered.
- Nominators must provide the written narrative of at least three (3) paragraphs in length, detailing why the nominated individual should be considered for a "10 under 40" Award.

### Other ...

- Please do not submit nomination in a folder or binder; Do not enclose videotapes, scrapbooks and other non-printed materials as we can not guarantee their safe return.
- Please provide sufficient background information on the nominee. Do not assume this information is known about the individual being nominated, please.
- The "10 under 40" nomination committee is made up of business, government and civic leaders from outside the community and will make their decisions based on the information provided in the nomination form.
